THE FOLLOWING EXCERPTS ARE FROM THE TOWNSHIP CODE, CHAPTER, 428-26, GOVERNING GARAGE SALES:

HOURS OF SALE SHALL BE BETWEEN 9:00 AM TO 5:00 PM

ONLY TWO PERMITS PER CALENDAR YEAR MAY BE ISSUED TO ANY ONE APPLICANT AT ONE LOCATION

SUNDAY SALES ARE PROHIBITED

NO ITEMS OF MERCHANDISE MAY BE DISPLAYED BEYOND (10) TEN FEET FROM THE FACE OF A GARAGE CONNECTED TO THE DWELLING HOUSE.

MERCHANDISE MAY BE DISPLAYED IN A DRIVEWAY, NOT, HOWEVER, BEYOND THE FRONT LINE OF THE DWELLING HOUSE, AND MERCHANDISE MAY LIKEWISE BE DISPLAYED ON THE REAR YARD OF SAID PREMISES FOR A DEPTH OF 10 FEET FROM THE REAR WALL OF SAID DWELLING HOUSE.

NO MORE THAN TWO GARAGE SALES SHALL BE AUTHORIZED AT ANY ONE TIME ON THE SAME STREET

ANY PERSON VIOLATING ANY OF THE PROVISIONS OF THIS CODE, SHALL UPON CONVICTION THEREOF, BE SUBJECT TO A FINE OF NOT MORE THAN \$1,000 OR NOT MORE THAN (90) NINETY DAYS IN JAIL, OR BOTH, AT THE DISCRETION OF THE JUDGE OF THE MUNICIPAL COURT.

I AGREE NOT TO HANG ANY SIGNS ADVERTISING MY GARAGE SALE ON ANY TOWNSHIP PROPERTY. I CAN PUT SIGNS ON MY FRONT LAWN; FIFTEEN FEET BACK FROM THE CURB LINE.

IT HAS BEEN EXPLAINED TO ME THAT IF I PLACE ANY SIGNS ADVERTISING MY GARAGE SALE ANYWHERE IN THE TOWNSHIP, I WILL BE FINED A MINIMUM OF \$250.00.

SIGNATURE OF APPLICANT

CHAPTER 462-4 OF THE MUNICIPAL CODE PROVIDES THAT NO SOLID WASTE GARBAGE, DISCARDED MATERIAL OR REFUSE MAY BE PLACED ON THE SIDEWALK OR CURBSIDE FOR COLLECTION BEFORE 4:30PM OF THE DAY PRIOR TO THE SCHEDULED COLLECTION DAY.

ANY PERSON VIOLATING THIS CHAPTER SHALL UPON CONVICTION, BE SUBJECT TO A MINIMUM PENALTY OF \$100.00 BUT NOT EXCEEDING \$1000.00 OR IMPRISONMENT OR COMMUNITY SERVICE FOR A PERIOD NOT EXCEEDING 90 DAYS AT THE DISCRETION OF THE JUDGE OF THE MUNICIPAL COURT. (466-23)
